BERNALILLO COUNTY WATER WELL ORDINANCE 2005-19 WELL WATER ANALYSIS REQUIRMENTS

Sec. 42-544. Use Requirements for Individual Wells

- C. No person shall use an individual well that produces water that exceeds the maximum contaminant levels allowed.
- E. Any new or modified well must be tested and meet water quality standards for parameters as determined by the County before final approval will be granted. Water sample collection, analysis, and analytical costs are the responsibility of the owner. The analysis should include, but is not limited to, the following:

total coliform	calcium
total Kjeldahl nitrogen (TKN)	magnesium
ammonia	chlorine
nitrate	bicarbonate
nitrite	total dissolved solids
sodium	pH
potassium	sulfate

Additional water sampling parameters may be required based on site conditions.

*** Please note, these same requirements apply to Multiple Household Wells.
