ACTION: Motion to approve the Management Negotiating Teams for the Bernalillo County Clerical and Technical Employees AFSCME Local 2260 (White Collar); the Corrections Officers AFSCME Local 2499; the Blue Collar Management Team AFSCME Local 1461; the Albuquerque Area Firefighters Local 244, Bernalillo County Chapter; and Bernalillo County Deputy Sheriff's Association collective bargaining negotiations.

SUMMARY:

The County has received requests that collective bargaining negotiations be reopened in accordance with the provisions of the current collective bargaining agreements and Section 2-201 et seq. of the Bernalillo County Code. There are three collective bargaining agreements requesting action: AFSCME Local 2260 (White Collar); AFSCME Local 1888 (Corrections Officers) and Albuquerque Area Firefighters Local 244, Bernalillo County Chapter.

County Code Sec. 2-212 Collective Bargaining prescribes that the County Commission shall designate the members of the negotiating team for the County.
