Dear Taxpayer:

Thank you for choosing the electronic bank transaction Tax Payment Plan.

By using the **Automatic Tax Bill Payment Option**, your Bernalillo County property tax bill payment will be automatically deducted from the U.S. checking or savings account you designate. Authorized half payments will be deducted on **December 09, 2015 and May 09, 2016**; full year payments will be deducted on **December 09, 2015**.

You will have time to review your tax bill before the amount owed is deducted from your account. The Bernalillo County Treasurer's Office must be notified in writing at least thirty days prior to the scheduled payment date to stop the automatic payment.

Sufficient funds must be available on the withdrawal dates, December 09, 2015 and/or May 09, 2016. This tax payment will appear as a debit on your account statement.

To participate in the Bernalillo County Treasurer's Automatic Tax Bill Payment Option, please:

1. Complete the enclosed Authorization Form. Only one authorization form can be used per financial institution. If additional forms are needed, contact the County Treasurer's Office at 505-468-7391.



Be sure to attach a voided **check** or **withdrawal slip** as shown on the Authorization Form. **Do not send a deposit slip.**

2. Return the completed Authorization Form and voided check/withdrawal slip no later than August 14, 2015, to:
