A. Department Updates

- a. *DSAP*
 1. *PIIP - averaging 90 admissions a week with 25% MDC diversion rate. Impacting the community positively. Molina has asked for a proposal as they would like to participate.*

2. *Two grants one for the assessment center and other for PIIP program to offset the costs; outcome in the next few weeks.*

b. MDC

1. *Inmate transports – 150 inmates spread between Cibola, Sandoval and Tarrant counties. Shipment on July 23 to Colorado was stopped by attorney general in CO they will not accept NM inmates.*

2. *Deadline for population reduction is September 1 per court order. August 8th meeting with Judge Parker to see if we have met the show cause order.*

3. *Decision on classification tool will be resolved soon.*

4. *June 26th Bernalillo County Criminal Justice Review Commission (HB608) met for the first time. Plan to meet monthly. Pat asked if a member of the community was a part of that commission. He would check with Chair Brasher of the possibility.*
