1 **ESTABLISHING LICENSE, PERMIT AND SERVICE FEES FOR CHAPTER SIX**
2 **OF THE BERNALILLO COUNTY CODE ENTITLED ANIMALS.**

4 **WHEREAS**, the Board of Commissioners of Bernalillo County has adopted
5 Ordinance No. 2008-15, creating a new Chapter Six of the Bernalillo County Code, and

6 **WHEREAS**, Chapter Six of the Bernalillo County Code provides for the
7 licensing of dogs, cats, and ferrets, and the permitting of animal related facilities, and the
8 impounding of animals; and

9 **WHEREAS**, the fees for animal licenses, permits and costs may need to be
10 periodically adjusted.

11 **NOW, THEREFORE, BE IT RESOLVED**, the Board of Commissioners of
12 Bernalillo County do hereby enact the following Animal License, Permit and Fee
13 Structure pursuant to Ordinance No. 2008-15.

BERNALILLO COUNTY CODE CHAPTER SIX (ANIMALS)

FEE SCHEDULE

<u>Pet Licenses</u>	<u>Yearly Fee</u>	<u>3- Year</u>
Neutered or spayed dog, cat, or ferret.....	\$10	\$22
Neutered or spayed dog, cat, or ferret owned by person 62 years of age or older.....	\$2	\$5
Unneutered or unspayed dog, cat, or ferret.....	\$20	\$50
Unneutered or unspayed dog, cat, or ferret owned by person 62 years of age or older.....	\$4	\$10

- Written certification from a veterinarian is required showing rabies vaccination date, rabies tag number, and spay/neuter status.
- Qualified service animals are required to be licensed; however they are exempt from the pet license fee.
- Pet license requirements, but not individual license fees, shall apply to all animals at a Hobby Breeder site.
- Information regarding animal's identification such as microchip, tattoo or tag must be provided to County at the time license is issued.

Reclaim Fee for rabbits, chickens, peafowl, geese, ducks and Similar size and type species.....	\$15
Reclaim Fee for goats, sheep, pigs, and similar sized species.....	\$40
Reclaim Fee for Emu, Ostrich, and similar sized species.....	\$50
Reclaim Fee for Horses, Cattle, and similar sized species.....	\$100
Daily Boarding for small livestock (accrues daily).....	\$5
Daily Boarding for large livestock (accrues daily).....	\$8
Pick-up Fee – Livestock (requiring additional transport equipment – per trip) (within Bernalillo County).....	\$50
Owner Surrender Fee for pick up of small animals (dogs, cats, ferrets).....	\$25
Dead Small Livestock pick-up.....	\$25
For multiple dead livestock pick-up at the same location.....	\$25 / animal
Dead Small Animal (dog, cats, ferrets) owners.....	\$25
Adoption Fee.....	\$varies
Trap Rental Fee – rodent (Non-refundable).....	\$10
Trap Rental Fee Lending Program – dog, cat, skunk, raccoon (Non-refundable).....	\$150

Trap Rental Fee – dog (Non- refundable).....	\$30

Reclaim fees will be doubled upon each additional impound.
