TITLE: Department of Homeland Security Initiatives

ACTION: Motion to:

1. Accept Sub-Grant Agreement #2006-BZ-T6-0036-BERNALILLO COUNTY BZPP for the allocation of \$189,000.00 from the U.S. Department of Homeland Security acting through the State of New Mexico Department of Homeland Security & Emergency Management.
2. Approve Financial Resolution **FR** **-2008** budgeting the grant amount of \$189,000.00.

SUMMARY:

The New Mexico Department of Homeland Security & Emergency Management under the Federal Department of Homeland Security has awarded Bernalillo County a total allocation in the amount of \$189,000.00 for the purchase of Buffer Zone Protection Plan (BZPP) equipment. BZPP provides grants to build security and risk-management capabilities at the State and local level in order to secure pre-designated Tier I and Tier II critical infrastructure sites including chemical facilities, electric power plants, dams, and other high-risk/high-consequence facilities.

The Bernalillo County Office of Emergency Management agrees to expend State of New Mexico Department of Homeland Security & Emergency Management grant funds in accordance with the Department of Homeland Security stratagem for the State of New Mexico, Bernalillo County. The Bernalillo County Office of Emergency Management agrees that it shall implement the program as detailed in this sub-grant agreement.
