  - b. **MCT/RRC and CET**
    - i. RRC has been up and running for one month, with over 2300 people moving through the center and half staying to utilize some sort of service. Onboarding 3 CHW's.
    - ii. MCT currently has 4 teams with one officer and one therapist, has been live for 4 months, and has at least one team 7 days a week. Community is receptive, and teams are being dispatched and requested by field officers. Barrier's: a) they are stretched thin and need more MCT officers, b) disconnect between APD and BCSO dispatch. CET following up with individuals at a later time.
  - c. **Crisis Continuum Update**
    - i. Continuing to build a plan, and the committee will continue to function in the same capacity. Providers Summit September 18 & 19; the 19<sup>th</sup> will be a full day of peer training.
