**1. CALL TO ORDER**

The meeting was called to order at 12:31 pm by Chair Richmond.

**2. APPROVAL OF AGENDA**

Richmond moved to approve the agenda, Scharman seconded, motion passed.

**2. APPROVAL OF MINUTES**

Richmond moved that the minutes of October 2013 be approved as presented, Sarate seconded, motion passed.

**4. NEW BUSINESS**

**Bernalillo County Sheriff's Office**

LeCompte spoke about the FY14 contract which BCSO is required to conduct 10 DWI Check Points, 25 Saturation Patrols (10 which were done during Balloon Fiesta) and 1 Underage Sting and the Special Operations Project during the Albuquerque Balloon Fiesta. During the Special Operation Project, BCSO conducted 10 Saturation Patrols with 12 DWI arrests, 2 felony DWI arrests, 15 misdemeanor arrests, 1 murder apprehension, 402 Citations – 311 Traffic and 5 seized vehicles. He mentioned the 23 court disposition cases which are currently pending.

**5. DSAP Update**

Carl Broach updated the Council on the status of the new PIIP building that is going up on the DSAP campus – mentioned that we were looking at a late December opening that would accommodate more individuals seeking PIIP services in a more comfortable setting.

He also updated on the status of PIIP admission numbers falling - mentioned that a meeting with Chief Breen and APD Commander would occur after planning council meeting and that the discussion would center on why numbers have taken a dip.

Fran Martinez Romero provided the Council with a financial update. The DWI Grant Council meeting was conducted on October 15, 2013. During this meeting, the DWI Grant Council approved Bernalillo County for the FY13 Distribution Reversion Grant Application in the amount of \$248,660 for FY14. The grant will fund New Mexico Highlands University for Continuing Care Services and a DWI Media Campaign. The DFA Implementation Workshop was conducted on October 16, 2013. During this meeting, Bernalillo County was advised of the FY15 grant awards: Distribution \$4,039,194.47 / DWI Grant \$164,591.11 and Detox \$1.7 million. Since the grant application forms and process have changed, the deadline dates will be released by the end of the year.
