A few residents have called the Sheriff's Office inquiring about the difference between a winter storm warning, winter storm advisory, or winter storm watch. It important to know the difference between these alerts so you may better plan and prepare for future changes in the weather.

The follwing information is courtesy of the National Weather Service and the American Red Cross:

#### Winter Storms

Winter storms can range from a moderate snow over a few hours to a blizzard with blinding, wind-driven snow that lasts for several days. Some winter storms are large enough to affect several states, while others affect only a single community. Many winter storms are accompanied by dangerously low temperatures and sometimes by strong winds, icing, sleet and freezing rain.

Regardless of the severity of a winter storm, you should be prepared in order to remain safe during these events. Winter Storm Outlook - Winter storm conditions are possible in the next 2 to 5 days.

**Winter Weather Advisory** - Winter weather conditions are expected to cause significant inconveniences and may be hazardous. When caution is used, these situations should not be life threatening.

**Winter Storm Watch** - Winter storm conditions are possible within the next 36 to 48 hours. People in a watch area should review their winter storm plans and stay informed about weather conditions.

**Winter Storm Warning** - Life-threatening, severe winter conditions have begun or will begin within 24 hours. People in a warning area should take precautions immediately.

## NEWS FROM THE **SOUTH AREA COMMAND**

First, from all of us here at the Sheriff's Department, we would like to wish you and yours and safe and happy holiday season, and a prosperous New Year. New Year is often a time for making changes, and here at the Bernalillo County Sheriff's Department, it is no different.

Beginning on Saturday, January 2nd, we will be implementing the new shift bid for all 3 of our Area Commands. If you are not familiar with what this means, here is an explanation: Twice a year, once in January and a second time in July, deputies assigned to the Field Services Division (patrol) are given the opportunity to select which Area Command they would like to work in and which time of day they would like to work, based on department seniority. This gives deputies a chance to work in various locations throughout the county, as well as the opportunity to experience different shifts over the course of the day.

Here in the South Area Command, we are retaining a good number of deputies who already work here, some remaining on their current hours, and others trying a different shift, but we look forward to keeping their knowledge and experience of our South Valley area, and utilizing them to continue providing quality service

to all of you. We are excited to be getting some personnel that are going through their first assignment to the South Valley Area as well. These deputies will all get the opportunity to see what a great community we have here, and will all work hard to earn your trust, and we have every expectation that they will do so.

Your shift supervisors for the upcoming bid will be Lieutenant Pete Golden and Sergeant Javier Madrid (day shift), Lieutenant Michael Fisher and Sergeants Rubel Tafoya and Jeffrey Hunter (swing shift) and Lieutenant Colleen Bultmann and Sergeant Patrick Rael (graveyard shift). If you need to speak directly with a supervisor, you can contact them through dispatch at 798-7000. As always, to have deputies dispatched for calls for service, also call 798-7000 and speak with a dispatcher, and in emergencies of course, call 911.

One thing on our agenda for the new year is to attempt to establish regular meetings between the Area Commander and business owners in the area to discuss the needs of the business community and their expectations and experiences with the Sheriff's Department. If you are a business owner and would like to discuss this further, please feel free to contact Captain Joshua Kingsbury at 314-0012 directly.

We are excited to get this new year started and have several new strategies in the works to continue the high level of service that we strive to provide you. #### BCSO offers the following advice: BE ON THE LOOKOUT FOR PORCH PIRATES/THIEVES

- If a suspicious vehicle is observed following delivery trucks in your neighborhood, please contact the Sheriff's Department immediately with a description of the vehicle, license plate, and occupants.
- Try to get physical descriptions such as gender, approximate height, weight, and what they are wearing so you can tell a deputy.
- Check with your delivery company to make sure your package was actually delivered. Know exactly what is in the missing box.
- If you have a security camera on your home, get a copy of the video to the Sheriff's Department.
- Ask your neighbors if their cameras captured the incident.
  - Many business offer deliver to a "safe location "such as CVS or Walgreens. Your package would be delivered there and you can pick it up. This is one option to ensure the security of your packages if you will not be home and present to receive them.



Evictions, Domestic Violence Orders, Emergency Restraining Orders and Writs of Restitution. What does all of this mean and how does it all get to the people in a timely manner? The service of the judicial processes can be very overwhelming and confusing. The Bernalillo County Sheriff's Department (BCSO) is responsible for the service of all judicial processes within Bernalillo County. The BCSO Civil Division can be reached at 505-468-7340.

Our team of sworn and civilian staff work diligently and are to support you through this process. The Sheriff's Department cannot provide legal advice or any other legal matter. For any legal advice or direction, you should contact an attorney or legal aid. However, the BCSO is able to provide the services to get any court order served professionally and within the timeframe allotted by the courts or state statute. There is a standard \$40.00 fee for all civil services.

Violence Orders Domestic and Restraining Orders are issued by a District Court Judge. Any direction and forms you may need can be located at the 2nd Judicial District Court located at 400 Lomas NW. Once an order has been issued, two copies of that order should be delivered to the BCSO Civil Division located at 400 Roma NW on the 1st floor. Our trained staff and Deputies will then submit one copy of the order to Warrants Section for input into the system. The second copy will then be assigned to a Civil Unit Deputy for service.

Information reference an eviction process or how to remove a tenant from a property can be found at the Metropolitan Court located at 401 Lomas NW. Once a landlord receives a judgement permitting the removal of a tenant from a property, the BCSO will make an appointment, complete service of this order and remove the tenant from the property. This service is also a \$40.00 fee.

Our Civil Unit Deputies are highly trained and well versed in the civil process. The process of service can be very stressful and taxing for everyone tinvolved. The BCSO takes great pride in the professionalism and the empathetic approach we take with each of our customers.

The BCSO Civil Division, located on the 1st floor of 400 Roma NW, is also home to our Records Management System (RMS). Our staff are able to offer the services and support needed to obtain any incident or crash reports generated by our agency. A report is usually available for release and pick-up within 7-10 days of the incident or crash. These reports are available at \$0.50 per page.

Due to the on-going COVID pandemic, our office lobby hours are currently Monday through Friday 10:00 AM until 2:00 PM. If at any time you are in need of immediate law enforcement assistance or are in an emergency, please contact our 24-hour dispatch center at 505-798-7000 or dial 911.





Members of the Special Victim's Unit and the Ghost Unit are vital participants in the Young Adult Court.

The mission of the Young Adult Court is to enhance long term public safety and reduce recidivism by working in partnership with young adults, supporting them to make a successful transition into adulthood. The Young Adult Court Program is a partnership of key criminal justice stakeholders. Honorable Judge Cindy Leos is the presiding judge with team members from the Second Judicial District Court Pretrial Services, Public Defender's Office, District Attorney's Office, Bernalillo County Sheriff's Department and community treatment providers. Young adult participants are between the ages of 18 and 25 and this is part of a pre-plea or post-plea program.

Detective Autumn Neas and Detective Justin Roybal have devoted a significant amount of time to this program. They are assigned several participants, for which, they complete check-ins on a weekly basis. Occasionally, they are required to do home visits, especially for participants on house arrest. The detectives ensure the participants have an open line of communication with law enforcement and the justice system.

Through this program, detectives have built strong community relationships with individuals who would normally have a very negative interaction and view of law enforcement. Their positive attitude and dedication to the mission of the program has had a tremendous influence on the lives of these participants.

# GENERAL SAFETY/CRIME REDUCTION SAFETY TIPS

Just a reminder now that Christmas has passed don't leave big boxes sitting out on the road or sticking out of a trash can to be picked up. Cut them up and dispose them at a recycle center if they won't fit in a bin. A box for a 65"TV or X-Box/laptop, etc., is just telling potential thieves what you have inside your home.

When taking down Christmas lights/decor, please be careful going up and down a ladder, and don't do it alone. Also don't do it if it's windy or if there is moisture outside, that makes surfaces and ladders slippery. There are thousands of trips to the Emergency room each year for people falling off a ladder

or the roof. And if you fall, and nobody is home to help you, it could make a bad situation worse.

There have been a couple of house fires in the county that were caused by space heaters and candles, so please be careful when using any indoor heating source, fireplace, wood-burning stove or candles, and make sure there are no flammable materials nearby, (blankets, firewood, newspapers, etc.) Don't leave the house with anything burning and make sure your pets can't knock them over if you have indoor animals. #### The Office of Senior and Social Services

The online programs have limited capacity so interested seniors are encouraged to register promptly.

#### Paint a Portrait

Free online painting classes will be offered in January, February and March 2021. The winter classes were promoted on the Senior Services email list and Facebook page and have already filled up. Additional classes are being contemplated for Spring. Participants receive an art kit by mail with a canvas, paints, brushes and a disposable apron. Participants need a computer, internet, a valid email address, and physical mailing address for mailing of materials. No painting experience is required.

Bernalillo County Senior and Social Services provides health and quality of life initiatives for Bernalillo County residents to improve economic wellbeing, education, health, and family & community development. Senior centers are currently closed due to the coronavirus (COVID-19) public health emergency. During normal times Senior Services does program development for county senior centers operated by the City of Albuquerque Department of Senior Affairs. Staff help serve meals and assist city staff with other planned activities. The department also addresses food insecurity, transportation barriers, and social isolation of seniors in the community.
