**SERVICE PROVIDER: ALBUQUERQUE CAB COMPANY**  
**SERVICE: TAVERN TAXI PROGRAM**  
**COMPONENT: PREVENTION (ADULT)**  
**BUDGET: \$200,000 (THROUGH LDWI DISTRIBUTION)**

**SCOPE OF WORK:** THE ALBUQUERQUE CAB COMPANY IS UNDER CONTRACT WITH DSAP TO PROVIDE TRANSPORTATION SERVICES FOR INEBRIATE PATRONS OF LIQUOR-DISPENSING ESTABLISHMENTS IN BERNALILLO COUNTY TO RESIDENTS WITHIN THE COUNTY. THIS SERVICE IS IN OPERATION FROM 10:00 PM TO 3:00 AM ON FRIDAY AND SATURDAY EVENINGS YEAR AROUND. SUNDAY SERVICE WAS CUT DUE TO FUNDING CUTS. THE SERVICE WILL ALSO BE OFFERED ON HOLIDAYS AT THE DISCRETION OF THE COUNTY AND AS FUNDING IS AVAILABLE. ADDITIONAL HOURS AND/OR DAYS OF SERVICE MAY BE ADDED, DEPENDING ON FUNDING AVAILABILITY AND SERVICE NEEDS.

DSAP ALSO PARTNERS WITH THE NEW MEXICO HOSPITALITY RETAIL ASSOCIATION FOR AN EXPANSION TO THE TAVERN TAXI PROGRAM. THIS EXPANSION IS KNOWN AS THE PICK ME UP, TAKE ME OUT PROGRAM. THIS PROGRAM OPERATES ON HOLIDAYS OR SPECIAL EVENTS AT THE DISCRETION OF THE COUNTY AND AS FUNDING IS AVAILABLE. THESE HOLIDAYS MAY INCLUDE ST. PATRICKS DAY, CINCO DE MAYO, INDEPENDENCE DAY, LABOR DAY, THANKSGIVING EVE, THE EVE TO CHRISTMAS EVE AND NEW YEAR'S EVE.

**MONITROING VISIT CONDUCTED: FRIDAY, MARCH 15, 2013**

**FINDINGS / CONCERNS:** WHILE THERE HAS BEEN SOME CONCERN WITH TIMES IN WHICH PATRONS ARE BEING PICKED UP, DURING THE MONITORING REVIEW OF THE PROGRAM, IT WAS NOTED THAT THE LONGEST PERIOD OF TIME IN WHICH A PATRON WAITED FROM THE TIME THEY CALLED IN THE REQUEST TO THE TIME IN WHICH THEY WERE PICKED UP WAS 22 MINUTES. THERE WERE NO FINDINGS OR CONCERNS NOTED DURING THIS REVIEW.
