For new wells, the measuring tube or airline must be installed by the well contractor for Applicant to qualify for water quality sampling and analysis to be provided by the County. If the tube/airline is not installed, the well permit fee will be covered in exchange for access for water level monitoring using hand tape or sonic water level meter, and sampling by County personnel will not be included. Measuring tube must be ¾" in ID minimum with stop pin or drilled cap at bottom and drilled holes in bottom 10 feet; airline/pressure line must be ¼ inch diameter (heavy duty poly or stainless steel) and pressure gauge must have minimum 1 psi gauge divisions. Measuring tube or airline must extend to within 10 feet of pump, and depth of tubing/airline must be permanently marked on well casing.

CONDITIONS AND APPLICANT RESPONSIBILITIES

I understand and attest that I am freely and willing volunteering for participation in this project. I understand that I am granting access to my property to Bernalillo County, or its agents, for water level measurement and water quality sampling purposes.	(Initials)
I understand that if this is an existing permitted well, I am not eligible to receive any type of fee reimbursement or other consideration. If this is a new or unpermitted well, I understand that aside from the County's waiver of the well permit fee and water quality analysis (as applicable) and obtaining resulting well monitoring data, I will not receive any compensation or consideration for allowing access to the well. I understand that if I wish to withdraw from the project prior to five years of program participation, I am responsible for reimbursing the County for any permit fees or analysis costs incurred as part of this agreement.	(Initials)
I understand that Bernalillo County is not waiving any permit requirements, issuing any type of permit or permission, or in any way indicating that the well is compliant with existing Bernalillo County or State of New Mexico requirements. I understand that Bernalillo County is not responsible for any existing problems or deficiencies in the well or pump conditions or other non-compliance with Bernalillo County or State permit or code requirements. I understand that the County, at its sole discretion, may determine which wells are suitable for water level and water quality monitoring, may determine which if any wells are suitable for addressing the County's project needs, may determine the timing and frequency of necessary measurements, and may allow or limit participation now or in the future. I understand that Bernalillo County personnel or its agents will be accessing my well during regular business hours (unless otherwise arranged with the County) to make water level and water quality measurements. Water level measurements are to be made using either a e-line, steel tape, or a sonic water level meter unless a measuring tube or airline pressure gauge has been installed. accuracy of the measurements for any purpose. (AS APPLICABLE FOR NEW WELLS) I understand that in exchange for having a well sample collected and analyzed by the County, I am having a contractor install a measuring tube in my well, and that I am solely responsible for payment to the Contractor for this installation. I understand that the County will not reimburse me or the Contractor for the additional expense. (Note: Tube must be 3/4" in ID minimum with stop pin or drilled cap at bottom; airline/pressure gauge must have minimum 1 psi gauge divisions and depth of tubing must be	(Initials)

I understand that collection of water level measurements using a measuring tube, airline/pressure gauge system, sonic meter or steel surveyors tape will in no way impair the operation or condition of the well or pump and that Bernalillo County is in no way responsible for the operation, maintenance, or repair of the well, pump, or piping now or in the future. I understand that before taking water level measurements, Bernalillo County personnel will need to access the well head (including loosening any insulating wraps) and temporarily de-energize any circuit breakers or switches connected to the pump to prevent electrical shock hazards. This means that the water from the well may be unavailable for short periods of time, not likely to exceed a maximum of 30 minutes.	(Initials)
I understand that Bernalillo County intends to restore power and return the well head to its previous condition to the extent practicable when the measurement is completed, but that Bernalillo County is not responsible for damages resulting from cold weather or other natural conditions.	(Initials)
