DSA Advisory Council Meeting Barelas Senior Center November 17, 2014

### Minutes

- Meeting Called to Order by Debby Knotts 12:15 pm
  - a. Present: Debby Knotts, Mabel Padilla, Marianne Chiffelle, and Susan White
  - b. October 2014 Minutes were approved.
  - c. November Agenda was approved.
- II. Center Manager: Introduction & Comments
  - a. Center Manager was not present at meeting; however, Rhonda Methvin provided a brief update. She said the Social Hall was stripped for pickleball and members were having a good time playing. The Veterans Garden was dedicated on November 10, 2014. A meeting was held to discuss the Barelas Fiesta with all the staff who were involved in the event to discuss the strengths and weaknesses.
- III. Public Participation
  - a. Cheryl Hunt, Senior Advocate, attended the meeting. She voiced her concern over the large population of seniors who do not have access to transportation.
- IV. Administrative Reports
  - Director Report Jorja was not present; therefore report was given by Rhonda Methvin and Karen Lopez
    - a. DSA Survey
      - 1. The DSA Questionnaire has been completed. They would like to distribute it to over 1,000 people possibly at alliance meetings, neighborhood association meetings, and Survey Monkey. The questionnaire should help establish where DSA is and where we need to go in the future. The target date for distribution is January 2015. Marianne suggested advertising it in the news media. Debby asked if perhaps it could be distributed as an insert in the Albuquerque Journal.
    - b. Santa Fe Visit and Senior Day January 27, 2015
      - There was discussion on when the best day for the trip would be either before or after Senior Day. Marianne said we need to make sure the date of the visit is placed on the calendar at the Round House. Rhonda suggested the council send out invitations. A date was not set, but Marianne will call to find out when the best day will be for the visit and Susan will check on finding an invitation to send out.

  - Kells & Craig Architecture firm has been selected. DSA hopes to have a design in place by next legislative session.

- a. Recreation Rhonda Methvin
  - 1. The Veterans Wall celebration was held November 14, 2014 at Highland Senior Center. We will be doing these walls at all of our centers starting next year. The Sports & Fitness catalog will be out in the Sunday Journal on November 23, 2014. We are still working on the improvements to Manzano Mesa such as the parking lot lighting issue. The North Valley fitness center should be complete in mid-January 2015. We should be conducting the walk-thru for the Highland addition this week. We will be meeting to discuss the bathrooms at Los Volcanes Senior Center. Staff will be getting new computers this month. We have the new membership card equipment and are working on the policies and procedures. Barelas will be the pilot location. We are still working on the Activities Catalog which will be out in January 2015.

Two new cooks and one Kitchen Aide started work today. One of the cooks will be assigned to North Domingo Baca so the kitchen can be fully utilized. Hopefully four Kitchen Aides will begin December 1, 2014.
