10. Brief description of what 1 st unit on the scene saw.	Upon arrival found single wide mobile home with moderate smoke showing from perimeter of roof.
11. Total time to bring fire under control	50 minutes
12. Anyone inside at the time of the fire. If yes, how many	Two people were sleeping when fire occurred
13. How was family alerted? (smoke detector, neighbors)	One person woke up to the smell smoke in the house and alerted the other occupant. No working smoke detectors were found in the home.
14. Injuries? If yes, include age, gender, transport info & injuries sustained.	No injuries reported
15. Fire Origin? Was it contained to origin?	The fire started by the front door in the wall. The fire then extended into the built up double roof space. The roof was a flat roof with a secondary wood truss pitched roof over existing.
16. Spread through %	60% of roof space was affected.
17. Smoke Damage (light or heavy smoke damage throughout)	Light smoke damage to the interior of the home.
18. Cause (determined/undetermined -->accident,natural,incendiary)	The cause was from improper electrical wire installation. The circuit was overloaded and created a short circuit. The short circuit created a fire in the wall at the front door. The cause is deemed accidental.
19. Estimated Damages (structural, contents/vehicle)	15,000 in damage to structure
20. Assisting Agencies like Red Cross, # of displaced?	AFD Arson investigator was used to determine cause and origin.
